#### Is This a Contract Violation?

Being aware of your contract and feeling empowered to recognize violations is a key component of maintaining our strength as an association. Take time to familiarize yourself with the contract. It is posted on SMEA's website and on the District's website.

My Principal has scheduled a mandatory staff meeting for coteachers during our lunchtime. Is this allowed?

Dear "Concerned",

Your principal's plan is a clear violation of Article IX-A. Teachers are entitled to a duty-free lunch. Meaning, you cannot be required to work during your lunch.

To use the contract to assess possible violations, start at the table of contents. Find the appropriate section. If you have questions about what you read, see your site representative for clarification.

#### Contract Says...

56 ARTICLE IX: HOURS 57

A. During a regular school day the hours of service shall be rendered as follows. A work day is a unit of seven and one-half (7 1/2) hours of school based service per day inclusive of a minimum of a thirty (30) minute duty-free lunch plus a minimum of a five (5) minute pass period and at the K-5 level, a duty free a.m. recess period. Such hours of service shall be directed by the unit mem-

#### Coming 2020: SCHOOLS & COMMUNITIES FIRST

The Schools & Communities First Act (SCFA) will hit the ballot box in November, 2020. This historic commercial property tax reform act would close corporate tax loopholes and bring much-needed funding to our schools and communities. It is NOT a new tax and does NOT impact residential property.

#### **Reclaim Funding**

Californians deserve better subsidize than to huge corporations that avoid paying millions in property tax while billions worldwide. making SCFA will close a corporate property tax loophole has drained billions over 40 years and will reclaim \$11 billion annually to reinvest in our local schools and communities.

#### **Fund Our Schools**

California is the 5th largest economy in the world, but ranks in the bottom 10 in the country when it comes to per pupil spending. SCFA will restore funding to schools and colleges for smaller class sizes, better teacher pay, and more resources for schools. It is time for corporations to pay their fair share.

#### **Homeowners Protected**

Residential, agricultural, and small business property would not be affected. The reform only applies to a small fraction of wealthy commercial and industrial property owners. Commercial property would be assessed at fair market value and California would still remain the lowest property tax rate in the nation.
